NECROLOGY



Word has been received that Stefan F. Firtko, author of the History of Midde Valley and a regular participant in meetings of the Swackhamer-Dufford Genealogy Society, died of cancer on November 16, 2023, at Genesis Healthcare in Easton, Pennsylvania.

The following obituary was provided by Naughright-Scarponi Funeral Home in High Bridge, New Jersey.

"Stefan F. Firtko (b. February 8, 1955; d. November 16, 2023) was born in Morristown, NJ, and lived in Bethlehem, PA and Kunkletown, PA, before moving to Easton, PA. He was the son of the late Frank J. and Margaret A. Hunadi Firtko. Stefan worked as a Librarian at Lehigh University in Bethlehem, PA until his retirement.

He was an avid reader. He was also a member of the Middle Valley Historical Society and wrote a book on the history of Middle Valley. Survivors include two sisters; Suzanne Firtko of New York, NY, and Margaret Trimmer of FL. Several nieces

and nephews including Lisa Schneider of Easton, PA and John Trimmer of Harpers Ferry, WV.

A graveside service was held on Monday, November 27, 2023, at 12:00 pm at Lower Valley Cemetery in Califon, NJ."

Gene Swackhamer, President of the Swackhamer-Dufford Genealogy Society said, "Stefan was a generous donor financially and of his time to the Society. He often did research for Society members and discovered several items of early Swackhamer history. One of his significant discoveries was a Janeway store ledger of transactions of farm and household items for Samuel Swackhamer of Middle Valley in the early 1700s."

Pat Barber of Glen Gardener, NJ, recalled "a really sweet, kind man always to be remembered for his love of history, and (he will be) missed at the Hunterdon County Historical Society and of course the Swackhamer-Dufford reunion."

Our Bulletin editor is currently paid for two issues each calendar year. Postage for mail distribution of the Bulletin has been donated for several years, representing an understatement of the total cost of production.

Donations to four charitable local Long Valley area organizations on behalf of the Society has averaged \$150.00. These organizations are Zion Lutheran Church which has provided the Society a meeting place since our beginning in 1953; The Washington Township Historical Society, which has helped preserve historical items and minutes; The Mt. Amwell Project, which helps care for the "Old Swack Church" of Lambert Swackhamer and the Middle Valley Cemetery Association, final resting place of numerous Duffords and Swackhamers.

THE FIRST TWENTY YEARS OF THE SWACKHAMER-DUFFORD GENEALOGICAL SOCIETY, 1953-1973

from Gene Swackhamer

Having just read the first twenty years of Society Bulletins, I am surprised by how similar the concerns of the past were to those of the current era. In spite of new technology, the introduction of color, and photographs (only one in the first twenty years) into the Bulletins, the officers and Bulletin editor continually pleaded for meaningful content, typed versus handwritten submissions, and more genealogy research material. Many of these laments have continued to exist.

In the early Bulletins there were frequent references to "the Society photo album," "the correspondence file," and "Society records." I have not seen any of these records. They seem to have disappeared over time. Perhaps some are in the Washington Township Historical Society library or have just disappeared with the death of officers. In any case, if you know the whereabouts of any old Society documents, please let a Society officer know. A good example is the 12-footlong scroll of Dufford family tree. I think it was last displayed in the barn at an anniversary meeting at the Raritan Inn. Should it be preserved? And if so, how, and where?

With few exceptions, each year since 1953 has had two Bulletin issues. Illness of the Editor or a special anniversary issue were reasons for a single issue or three.

Nearly all correspondence in the first twenty years was by letter. By counting references to a letter, it appears that up to twenty letters per year was not unusual – thus the correspondence file. A letter today is a rarity. Emails are the vehicle of choice. Most of the communication of the current era is a search for an ancestor compared to relaying information on Florida vacations, marriages, births, deaths, and family recognitions of the first twenty years.

It appears that the Historian officer position of the separate societies prior to 1953 was melded into the Bulletin Editor position and the Bulletins of the combined societies became the historical record for the new combined society. As an unincorporated society, it was easy to retain and to change officer titles and responsibilities and to utilize individual talents and availability. Each Bulletin included the names of annual reunion elected officers or individual in an acting capacity as remains the case presently.

Seven individuals served as president of the Swackhamer-Dufford Genealogical Society in the first twenty years as shown in the following table. Even though the Society is an unincorporated entity it surely had a constitution and by-laws adopted at one of the 1951-53 reunions, but I have never seen one.

My summary observation of our first twenty years is that family reunions were a big annual event that drove much of the yearly effort. A mailing of nearly 300 Bulletins twice a year then remains nearly the same now. A few individuals (4-6) at any given time have provided sufficient stable leadership to ensure a solid society base for the future.

Note: The 2024 summer Bulletin will report on the 1974-2000 era and a future issue will conclude the series with the 2000-2025 period. The best official record of the Swackhamer-Dufford Genealogy Society is available in complete sets of Bulletins at three locations: The Alexander Special Collections at Rutgers University Library, The Washington Township Historical Society Museum/Library and with Gene L. Swackhamer in Maryland.

GENEALOGY RESEARCH THOUGHTS

The search for our Dufford and Swackhamer European ancestry origins that dominated annual meeting reunion discussions for more than two decades has mostly ended. The discovery of Samuel Schwechheimer's (Swackhamer) birthplace in Altlussheim, Germany and Philip Dufford's family baptisms in Langensoultzbach, France (his last residence before departure for the American Colony in 1738) provided substantial evidence of European origin.

Documentation of these facts can be found in "Early Germans of New Jersey," by Theodore Frelinghuysen Chambers, last printing by Genealogical Publishing Company, Baltimore, Maryland, 1982 and "Eighteenth Century Emigrants from the Northern Alsace to America," by Annette Kunselman Burgert, Picton Press, Camden, Maine 1992.

Although finding the origin of our families was a significant breakthrough, it has not answered all the questions. Questions such as the following: What skills did they bring with them to America? Why did they travel to New Jersey and not stay among Germanic speaking countrymen in Pennsylvania? What formal education did they have? Did family members perish in crossing the Atlantic Ocean?

Perhaps someone will be willing to tackle one of these types of questions, but the few members interested in "family history" research seem more interested in U.S. ancestorial questions and connections.

In my family's case and for several others who descended from Daniel Swackhamer in Ohio, there is a gap of documents and proof of connection to Samuel in New Jersey. To close that gap, I chose a mathematical approach and Ancestry.com.

In mathematics there is a law of association in short that says if a + (b + c) = (a + b) + c then a(bc) = (ab)c and these terms or factors (a, b, and c) may be associated in any way desired. In a like manner, if two or more Swackhamers have identical DNA at the 37-marker level and each have documented proof of descendancy from Samuel, then any other person with identical DNA to these descendants will also be a descendant from Samuel. Such is the case for we who are descendants from Daniel with matching DNA to three other Swackhamers descended from Samuel.
